PROPOSAL(S): RENEWAL OF EXISTING PARKS AND RECREATION MILLAGE

Shall the Charter Township of West Bloomfield be authorized to continue to levy the previously approved ¼ of one mill, as reduced by the millage reduction as required by law based upon the so-called Headlee Amendment, for a period of ten years (2011-2020, inclusive), only for acquisition, development, maintenance and operation of Township parks and places of recreation by the West Bloomfield Parks and Recreation Commission. Approval of this proposal would renew the tax limitation increase of approximately .2200 per \$1,000 of taxable value on all taxable property in the Township. It is estimated that this proposal would result in the authorization to collect \$924,000 in the first year if approved and levied.
